#### FOR YOUNG AFRICAN LEADERS

he Mandela Washington Fellowship (MWF) for Young African Leaders, is the flagship program of the Young African Leaders Initiative (YALI) that empowers young leaders from Sub-Saharan Africa through academic coursework, leadership training,

networking opportunities. The Fellowship, which began in 2014, has already engaged 3,000 young leaders from every country in Sub-Saharan Africa. Through this initiative, young African leaders are gaining the skills and connections they need to accelerate their own career trajectories and contribute more robustly to strengthening democratic institutions, spurring economic growth, and enhancing peace and security in Africa. The Mandela Washington Fellowship is a program of the United States Government. The U.S. components are administered by the U.S. Department of State's Bureau of Educational and Cultural Affairs and supported by IREX, a U.S. non-governmental agency.

The Fellows have established records of accomplishment in promoting innovation and positive impact in their organizations, institutions, communities, and countries. The first four classes of Fellows represented all 49 countries in Sub-Saharan Africa and included equal numbers of men and women.

The 2018 class of Mandela Washington Fellows arrive in Mid-June 2018 for fiveweeks of intensive executive leadership training, networking, and skills building, followed by a 3-day Summit in Washington, D.C. that all 700 fellows will attend.

Host institutes focus on skills development in one of three areas:

ü Business and Entrepreneurship ü CivicLeadership ü PublicManagement

Howard University (HU) is a comprehensive research university, unique and irreplaceable, defined by its core values, the excellence of all its activities in instruction, research and service, and by its enduring commitment to educating youth, African Americans and other people of color in particular, for leadership and service to our nation and the global community. Howard University offers the Public Management track. This is drawn from the university's unique set of expertise and resources. Public Management Institutes are tailored to those who work, or aspire to work, in all levels of government, regional or international organizations, or other publicly minded groups and think tanks. The Institutes introduce Fellows to U.S. models and best practices while building technical and leadership capacity in areas such as citizen engagement, human resource management, public financial management and the intersection of government with business and

civil society. The overarching objective of the Mandela Washington Fellowship Institute in Public Management is to provide a culturally diverse experience to Young African leaders to assist in the building of capacity as it relates to public management on the African continent.

Historically, policies encouraging the use of information, technology (home grown through education/ research or through technology transfer and adaptation) through competiveness and inclusiveness (diversity) has been the key to sustained economic growth. In this program, this aspect alongside the understanding of the importance of growing small business for economic growth will be emphasized through case discussion and open discussion using research papers/ case studies to place the dialogue in context. Academic study is augmented by workshops, mentorship, peer collaboration, and networking opportunities with recognizes leaders in their perspective fields. The academic content addresses topics such as good governance, female leadership in government, woman and girl empowerment, gender stereotypes, Ethics and Value Based Leadership, the role of technology and social media in re-shaping governance. Fellows will be prepared for an academically and professionally challenging program.

#### HOWARD UNIVERSITY: AN OVERVIEW

In November 1866, shortly after the end of the Civil War, members of the First Congregational Society of Washington considered establishing a theological seminary for the education of African- American clergymen. Within a few weeks, the concept expanded to include aprovision for establishing a University. Within two years, the Universityconsisted of the colleges of Liberal Arts and Medicine. The new institution wasnamed for General Oliver 0. Howard, a Civil War hero who was both a founder of the University and, at the same time, commissioner of the Freedman's Bureau.



The University charter as enacted by Congress and subsequently approved by President Andrew Johnson on March 2,1867, designated Howard University as "a University for the education of youth in the liberal arts and sciences." TheFreedmen's Bureau provided most of the early financial support of the University. In 1879, Congress approved a special appropriation for the University. The charter was amended in 1928 to authorize an annual federal appropriation for construction, development, improvement and maintenance of the University.



Howard University as one of the nation's leading research universities is dedicated to educating students from diverse backgrounds at the undergraduate, graduate, and professional level, with a particularfocus on African-American students, as well as those of all other racialand ethnic groups from the United States and around the world. The University received its first accreditation from the Middle States Association of Colleges and Schools in 1921 and has had itsaccreditation reaffirmed by the Association at every required intervalthereafter.

Howard is a unique university with a special mission that addresses the higher education needs of the nation and the world. Since its founding, Howard has been open to men and women from all racial and ethnic groups. The Universityhas awarded more than 100,000 degrees in the arts, sciences and humanities. Howard ranks among the highestproducers of the nation's Black professionals in medicine, dentistry, pharmacy, engineering, nursing, architecture, religion, law, music, social work and education. The University has long held a commitment to the education and advancement of disadvantaged persons in American society and throughout the world. The goal is the elimination of inequities related to race, color, social, economic and political circumstances.

The University's academic programs are offered by 13 schools and colleges: the College of Arts and Sciences; the School of Business; theSchool of Communications; the College of Dentistry; the School ofDivinity; the School of Education; the College of Engineering andArchitecture; the School of Law; the College of Medicine, the College ofNursing and Allied Health Sciences; the College of Pharmacy; and theSchool of Social Work.



Howard's motto, Veritas et Utilitas, or Truth and Service, is woven throughout its academic, student, faculty and research programs. Students, faculty and staff are actively involved in community, local, national and global serviceefforts to create awareness and provide solutions to help improve the quality of life in many communities.

Howard University Hospital, has over the course of its 145-year history of providing the finest primary, secondary andtertiary health care services, a Level 1 Trauma Center, and has become one of the most comprehensive health carefacilities in the Washington, DC metropolitan area.

The College of Medicine is internationally regarded for its illustrious legacy of training students to become competent and compassionate physicians who provide health care in medically underserved communities at home and abroad. The College is a national leader in studying health disparities among people of color and is one of America's top institutions for training women surgeons. The Howard University Health Sciences division includes the Howard University Hospital and the Colleges of Dentistry, Pharmacy, and as well as Nursing and Allied Health Sciences.

For more than 140 years, the Howard University School of Law has served as an advocate for social justice and as anarchitect of social change. It has produced more than 4,000 social engineers including the first African-AmericanSupreme Court Justice, noted legislators, civil rights attorneys, mayors and public officials across the United States. In2012, the Law School was ranked among the top 20 public service schools by National Jurist magazine

Howard is a leader in STEM fields. The National Science Foundation has ranked Howard as the top producer of African-American undergraduates who later earn science and engineering doctoral degrees. The University also produces more minority doctoral graduates in computer science than any other university in the nation and boasts nationally ranked programs in social work, business and communication sciences and disorders. In 2013, TheWashington Post named Howard "An Incubator for Cinematographers."

The University library system, typifying Howard's commitment to research, contains more than two million volumes and is a member of the Association of Research Libraries. Among the system's many resources are the state-of-the-art, Louis Stokes Health Science Library and the Law Library, both of which opened in 2001. In addition, the Moorland-Spingarn Research Center houses one of the world's largest and most comprehensive research collectionsdedicated to documenting the history and culture of people of African descent throughout the world.

The University has an array of media outlets that address the educational, social, economic, and informational needs of the academic and wider communities. Its radio station, WHUR-FM, and television station, WHUT- TV, a PBS affiliate, serve the Washington metropolitan area and beyond. Each provides training laboratories that assist in preparing students for professional broadcasting and other careers.

Howard University Television, WHUT-TV, was founded in 1980, and was the first African-American-owned publictelevision station in the nation. It is also the only university-licensed public television station located in the metropolitan Washington viewing area, which includes more than three million households. www.whut.org.

The University's commercial radio station, WHUR-FM, has been broadcasting from more than 34 years andis aleading station in the Washington metropolitan area. It is also the first and only station in the area to broadcast high-definition radio. www.whur.com and www.whurworld.com. Celebrating over 30 years on air, WHBC Howard University's student operated radio station is a major media outlet for the student body. WHBC Channel 51 has thecampus' ear and is a part of the Howard student collegiate lifestyle. The University's main campus is located in Washington, DC, within five miles of the United States Capitol and consists of more than 57 buildings on more than 89 acres of land. It also maintains a 22-acre West Campus in upper Northwest Washington, which houses the Law School; a 22-acre campus in Northeast Washington; and a 108-acre Beltsville, Maryland research campus, which houses a major atmospheric science research facility. The 450 licensed-bed university hospital (Howard University Hospital) provides services for a significant of the Washington, DC metropolitan community, in addition to providing a clinical setting for trainingphysicians, nurses, and other healthcare providers.

The University fields teams in 19 varsity sports including basketball, football, lacrosse, soccer, softball, swimming,tennis, indoor and outdoor track, and volleyball. Howard has more than 10,000 students from virtually every state, the District of Columbia and more than 70 countries.

Today, Howard University is one of only 48 U.S. private, Doctoral/Research-Extensive universities. Its students enjoy academic pursuits in more than 120 areas of study leading to undergraduate, graduate, and professional degrees. Over the last 20 years, the University has produced four Rhodes Scholars, 11 Truman Scholars, two MarshallScholars, over 80 Fulbright recipients, 22 Pickering Fellows and one Schwarzman Scholar. The University continues toattract the nation's top students and produces more on-campus African- American Ph.D. recipients than any otheruniversity in the United States. Anicet Ntisumbwa has more than three years of experience in public health management, particularly in working to bridge the gaps between global health research, policy, and intervention to achieve a strong health system in Sub-Saharan Africa. His research interest is the connections between climate change, food security, and noncommunicable diseases in the context of sustainable development in low-income countries, including Burundi. He has a doctorate in Medicine from the University of Burundi. Currently, he is program director at Ubuntu Village of Life project. There he contributed to the opening of Ubuntu Medical Clinic, which offers a holistic healthcare program in southeastern Burundi. He also contributed to the establishment of a vocational training center, which focuses on empowering unemployed rural youth by teaching them English, computer science, and agribusiness. Currently, he is solutions architect and digital solutions manager at VillageReach, where he fosters eHealth and leads digital solution initiatives in Angola, Côte d'Ivoire, Malawi, Mozambique, and other countries. His role enables him to work collaboratively with multiple stakeholders, including governments, non-governmental organizations, donors, and the private sector. For several years, Dércio has volunteered as a youth mentor in the Maputo and Gaza provinces of Mozambique, where he lectures on the basics of computer use and computer science.
